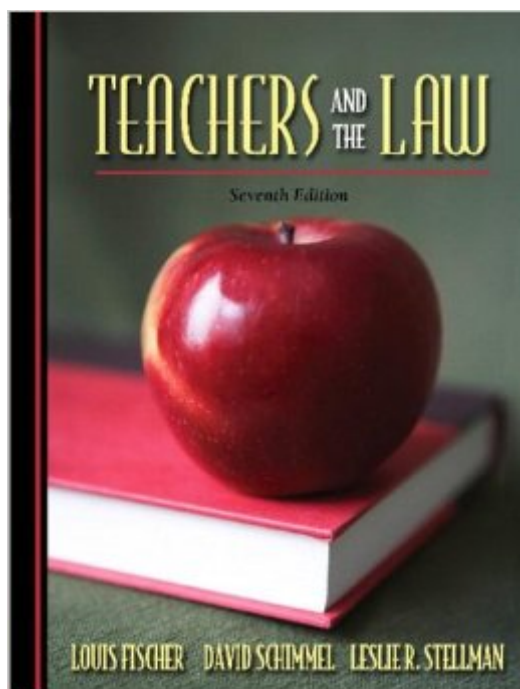

Different cases are also introduced, discussed and their significance in education is explored. All kinds of issues are discussed, from what constitutes libel to marriage between administrators and teachers within the same school.
